

## Guiding the Next Generation of Macomb Lawyers

Every lawyer remembers that uneasy stretch between finishing the bar exam and waiting for results. It's a strange mix of exhaustion, hope, and anticipation — the culmination of years of study, sacrifice, and late nights, followed by an almost unbearable stillness.

I remember the moment vividly, it was a chilly Halloween day in 2009, and I had been checking the mail as if it were my full-time job for weeks. Every day, I'd walk to that mailbox with a racing heart, hoping that envelope would finally appear. And then, on that day, there it was, correspondence from the Board of Law Examiners.

My heart dropped. I stood there, staring at that envelope, realizing that everything I had worked for was inside every class, every exam, every sleepless night, it all came down to this one piece of paper. I didn't even make it back upstairs to open it. I stood in the middle of the lobby of my condo building, peeled open the envelope, and peeked inside just enough to see one word: "Passed."

I remember exhaling in a way I hadn't in years. I leaned against the counter, overwhelmed with relief, gratitude, and disbelief. It was one of those moments that define you, the kind that reminds you what it means to work hard, persevere, and finally see it all come together.

Whenever I question what I'm doing or feel worn down by the demands of this profession, I think back to that moment, that younger version of myself who was filled with excitement, hope, and possibility. I remember how much it meant to me to be able to finally call myself an attorney and to make that most anticipated call to my mom to tell her, I passed!

For so many of today's new lawyers, that moment of accomplishment is just as powerful. However, the world they're stepping into is very different.

This new generation of attorneys has faced challenges unlike any we've seen before. Many of them went to law school during the pandemic. Some attended classes entirely online. Their professors and classmates existed in tiny boxes on a computer screen. I am proud to announce the launch of the Macomb Mentorship Program, an initiative designed to pair newer attorneys with experienced practitioners in our community. The goal is to provide meaningful, ongoing support to attorneys within their first five years of practice while giving seasoned lawyers an opportunity to share their knowledge, perspective, and professional values.

Your participation is vital to the success of this program. Interested members will fill out a short questionnaire and we'll use that information to create thoughtful, meaningful pairings that foster both professional and personal connection. Each pairing lasts one year, with flexibility for a continued connection. Participants will be encouraged to meet at least quarterly. Discussion topics may include courtroom practice, ethical dilemmas, client relations, marketing, time management, and work-life balance.

For our new attorneys, I want to say this: you are entering a profession that is challenging, yes, but also incredibly rewarding. Don't be afraid to ask questions. Don't be afraid to reach out. The lawyers who have been practicing in this county for decades have so much wisdom to share — and they want to help you.

And to our more experienced members: you are the guardians of this profession. You've seen its highs and lows, its changes and constants. Your guidance, patience, and professionalism are the very things that will sustain our bar for generations to come.

As we welcome a new group of lawyers who have just received their bar results, I encourage every seasoned attorney reading this to remember your own moment, the day you opened that envelope and saw the word "Passed." Remember what that meant to you. Remember the hope, the pride, and the sense that the world was wide open before you.

# Macomb County Prosecutor Streamlines District Court Adjournments to Improve the Filing Process

The Macomb County Prosecutor's Office has been modernizing its case management process by improving the flow of information between prosecutors and defense attorneys. One of the steps taken is aimed at streamlining adjournment requests in an efficient and user-friendly manner. Attorneys and other filers can now use the county website to electronically request adjournments.

The online request form for District Court adjournment requests is accessible from the Macomb County Prosecutor's Office website and provides users with the ability to complete a web-based form that is automatically routed to the prosecutors assigned to that court.


The form is available on the Prosecutor's Office website at https://macombgov.org/prosecutor and provides several advantages:

• Efficient Response Time: By enabling the Prosecutor's Office with the ability to process adjournment requests electronically,

the Prosecutor's Office is able to reduce delays in response time, reduce angst for crime victims, and further improve equity for defendants and their legal representation.

- Increased Accuracy: Digitally accepting adjournment requests allows the Prosecutor's Office an opportunity to ensure that the request reaches the appropriate prosecutors and thus, improves the overall function, efficiency, and accuracy of the filing process.
- Improved Access to Justice: When effective case flow and trial management is improved, the quality of justice is enhanced. By providing digital solutions for requesting adjournments, the Prosecutor's Office is able to properly manage workflow and further ensure procedural due process.

The online form is specifically for Macomb County district courts. It does not apply to Macomb County circuit court filings because the circuit court has its own efiling system.

## Pilot Child Support Specialty Court Anticipated to Launch Before Year's End

Protocols are being finalized for the Pilot Child Support Specialty Court, a voluntary program designed to give parents with significant child support arrears one last opportunity to get back on track and avoid a permanent felony conviction.

#### **Purpose and Goal**

With \$300 million in arrears in Macomb County and \$5.6 billion statewide, the need for innovative solutions is clear. The goal of the program is simple:

- Ensure children receive the financial support they are owed.
- Address barriers—such as unemployment or lack of job skills—that keep parents from paying.
- Provide accountability paired with resources, so parents can succeed.

### **Process and Program Overview**

When a parent in Michigan falls more than \$5,000 behind and has made no payments for at least three months, the Macomb County Prosecutor's Office reviews the case for criminal prosecution. The Office investigates ability to pay and will exhaust all efforts to work with the parent on payment options. If that effort does not succeed, a felony non-support charge is issued.

The Child Support Specialty Court will offer "another bite at the apple." Participants will sign an agreement of program requirements and consequences. They will plead guilty to the felony charge but, while participating in the program, the sentence will be delayed. They will be closely supervised, required to maintain employment and make child support payments, and supported with services through Michigan Works and other partners.

Michigan's Clean Slate Law has opened new employment opportunities, and job placement is available even for those with soft felony convictions. Applications will be considered on a case-by-case basis.

For attorneys: The Child Support Specialty Court provides a new option to provide training and job support while helping parents avoid the long-term consequences of a felony conviction while ensuring children receive the support they deserve.

Prior to his appointment to the 37<sup>th</sup> District Court, Judge Bieda was appointed by the Governor to work on the development of the theme and design of the Michigan Innovation Dollar in April 2022.

The legal tender collector coin is currently offered by the United States Mint, and is available at www.usmint.gov.

The Michigan Innovation Dollar is composed of the same composition and size as the Sacagawea Dollar coin first issued in 2000. The Michigan Innovation Dollar represents the innovation of the automobile assembly line and the release

According to the U.S. Mint's narrative, the coins in the American Innovation Dollar series are to be issued depicting designs which symbolize "the willingness to explore, to discover, and to create one's own destiny." The coin program showcases an innovation, innovator or group of innovators from each State or territory. The reverse of each coin depicts an innovation or innovator. The uniform obverse design of the Innovation Dollar series features a three-quarters view of the Statue of Liberty (Liberty Enlightening the

World), designed by Justin Kunz, along with the denomination \$1 Dollar and the national motto, "In God We Trust."

A formal presentation of the coin to Michigan's Governor occurred on June 3, 2025.

## Clerk Anthony Forlini Shares Office Advancements with MCBA Members

The Macomb County Bar Association recently hosted an engaging presentation featuring Macomb County Clerk Anthony Forlini, held in the Jury Room of the Macomb

County Circuit Court. The event was designed to inform MCBA members about the significant strides made in the Clerk's Office under Clerk Forlini's leadership, and to recognize ongoing efforts to enhance efficiency, accessibility, and service delivery.

Clerk Forlini outlined a clear, three-phase vision for transforming the Clerk's Office:

Phase 1 focused on restoring respect and accessibility to the office.

This included improving the public-facing appearance of the office and ensuring it operated with greater efficiency.



**Phase 2** emphasized running the office like a private business, with measurable improvements in service times. For example, what once took 45 minutes—such as obtaining

a Concealed Pistol License (CPL) or a marriage certificate now takes just five minutes from start to finish.

Voicemail systems have been eliminated entirely; when you call the Clerk's Office, you speak to a real person and get the help you need immediately. Technology upgrades have also been implemented to streamline internal processes and enhance public service.

Phase 3 looks toward the future, with initiatives including tract indexing, improved storage solutions for records, continued digital scanning, and a rebranding of judicial court clerks. Cross-training staff and eliminating siloed workflows has further improved overall office efficiency.

In recognition of these efforts, the Macomb County Clerk's Office has received two national awards out of 5,000 municipalities eligible and only 28 awards given. The Macomb County Clerk's Office was the only office in Michigan to win and the only office in the country to receive two awards.

The Macomb County Bar Association thanks Clerk Forlini for his commitment to innovation and transparency, and for taking the time to share these impressive developments with our members.

## Practical Collection: The Uncharted Frontier (Part Two)

Last month, I wrote about how to preserve your fees with written contracts and collection of personal information. In this second part of my four-part series on collection, I will discuss how to handle a fee dispute, and when you sue to collect your fees. As always, these tips come from personal experience, and I employ these tips when I collect my fees, and fees for other attorneys.

If a dispute arises during litigation and before final judgment, you must seek a withdrawal order from a court. An attorney only serves a client in a pending case until a final judgment is entered (unless an attorney opts to continue working on the matter to extent possible)<sup>1</sup>. An attorney is permitted to withdraw from a case when "the representation will result in an unreasonable financial burden on the attorney or has been rendered unreasonably difficult by the client."<sup>2</sup> An attorney is obligated to continue working on a pending case until a withdrawal order or substitution order are signed.<sup>3</sup> This is relevant to the accrual of a claim for malpractice. Malpractice (as a civil claim) has a two-year statute of limitations.<sup>4</sup> As an affirmative defense, however, there seems to be no limitation on raising it.

An attorney does not "discontinue servicing" his client for purposes of the malpractice statute of limitations until the client, or the court, relieves the attorney of the latter's obligations or until the attorney completes a specific legal service that the attorney was retained to perform.<sup>5</sup> In one case, a court treated the accrual of a malpractice claim when the client terminated the relationship by letter, though the withdrawal order was signed four months later.<sup>6</sup> Another court treated the claim's accrual when the client hired other attorneys and terminated the prior attorney's power of attorney.<sup>7</sup> Best practice dictates that you wait more than two years after you receive a withdrawal order before filing a lawsuit. When there is no litigation (or none was ever pending), it is best to wait two years after the last legal service is completed, or when the client demands that you cease your services. In such instances, you should draft a letter indicating that, as of the last date of service (or when the client discharged you), the representation has concluded.

When collecting your fee, you should send a letter demanding payment. This is because one claiming a substantial breach of contract should provide an opportunity to cure.<sup>8</sup>

Before mailing a demand letter, confirm the former client's address is correct with a postal verification. Every jurisdiction is different, so check the USPS website, or ask a local branch how to do this. At this juncture, you are permitted to disclose "confidences or secrets necessary to establish or collect [your] fee" so this should not inhibit you. After you send a demand letter, you should file your lawsuit with three principal claims. For me, the three claims are: (1) breach of contract, (2) unjust enrichment, and (3) action on an account stated. The first claim speaks for itself. You must affix a copy of the contract to the complaint, and plead that all conditions precedent to the defendant's performance have occurred. It is necessary to add your attorney's fees to the damages you seek.

As for an unjust enrichment claim, <sup>13</sup> you should plead that you are requesting this as alternative relief <sup>14</sup> in case a court voids or disregards your contract. You should also try and avoid referencing the underlying contract as the factual basis for the claim since an unjust enrichment claim cannot be maintained when there is a written contract covering the same subject matter. <sup>15</sup> Add all your damages into your request for relief when pleading this claim.

An account stated claim is demonstrated differently. Proof of mutual dealings between two parties "that have been adjusted, settled, and [show] a balance struck, the law implies a promise to pay that balance." When invoices are sent out, and either paid, or not objected to within a reasonable time, an account becomes stated. You should file the complaint with the invoices detailing payments and the balance. You should also file an affidavit of account stated as an exhibit with facts sufficient to establish the account. A failure by the defendant to object with a counter-affidavit creates prima facie evidence of the account's existence.

You should request a sum certain, with all contractual interest and prejudgment interest included,<sup>20</sup> and taxable costs in your complaint.<sup>21</sup> You should always seek to personally serve a defendant, though certified mailing is permitted.<sup>22</sup> You should use a professional process serving company to personally serve a defendant and defeat claims of surprise.<sup>23</sup> Make sure to file a proof of service. After 21 days from the date of personal service (or 28 days after mailing, with proof of receipt provided), you may file for a default against a defendant.<sup>24 25</sup> After 7 days after service of the default, you may file for a default judgment using the MC 07a form for a sum certain.<sup>26</sup> If you plead a sum certain, you do not need to give notice of entry of a default judgment until after it is entered.<sup>27</sup> Make sure your math is correct so the default judgment is not rejected. After 21 days from entry of a judgment, you may begin to collect.<sup>28</sup>


If the defendant decides to litigate, then it is time to do what we do best. Performing appropriately in the underlying representation, coupled with my tips in these two articles, will provide you the best chance to prevail. Hiring other counsel, however, may be best in this situation. In the next article, we talk about how you will collect your judgment.




