

What Does a Return to Phase Four Really Mean?

Recently, as a result of COVID 19 numbers, State Court Administrative Office (SCAO) sent a m emorandum to all state courts advising them that they would be moved to Phase IV immediately. The memorandum stated in relevant part:

- Chief judges have full discretion to protect court staff and court users, consistent with local public health guidance and MIOSHA guidelines.
- Proceedings will be conducted virtually to the maximum extent possible, consistent with Administrative Order No. 2020-6 (extended by Administrative Order No. 2020-12).
- In-person court proceedings, including jury proceedings, will be permitted, consistent with local public health guidance and MIOSHA guidelines pertaining to social distancing, capacity June 21, 2021, limitations, mask requirements for court participants, etc. Courts may implement jury practices as provided in LAO 51.
- The public may be required to wear masks pursuant to local public health guidance and MIOSHA guidelines.
- Judges retain the discretion to require individuals in the courtroom to use masks generally or in specific cases, particularly cases involving persons who are at an increased risk of severe illness from COVID-19.

- Any person desiring to wear a mask shall be allowed to do so
- Upon a local resurgence of COVID-19 cases in a local jurisdiction, the court may be required to implement additional COVID-19 mitigation measures provided for in RTFC Phases 1-3.

By and large the feedback that many lawyers have been giving me is that many routine matters should continue indefinitely as the technology allows attorneys to be more efficient and attend to multiple matters that are being heard in courts that are substantially distanced geographically. The expansion of electronic filings has substantially saved on expenses related to hand delivery or mailing pleadings to the court.

What does this mean for us? As many practitioners are aware, the response to this memorandum has been all across the board. While some courts have continued to conduct themselves nearly entirely via Zoom other courts have taken the position that business is going to resume in the very same way that they did two years ago. Even different judges within the same courthouse will handle their dockets in very different ways.

The Macomb Bar Association wants to hear input from both the bench and the bar about how we can still conduct hearings to the fullest extent possible electronically, serve the interest of justice and make matters more efficient for all parties.



Crawling, Indexing, and Ranking

Do you ever wonder how search engines give you the answers to what you are searching for? Search engines are complex computer programs and they start to prepare for your search even before you type

anything. They do this by crawling, indexing, and ranking.

The first step is crawling. Web crawlers, also known as spiders, are responsible for finding public information on the internet. They scan the internet and find servers hosting websites. These crawlers search every website for information

including number of pages, content, images, video, formatting and links leading to more pages and websites. There are over 130 trillion pages on the internet that crawlers continuously search.

The information the crawlers find needs to be organized, sorted, and stored. This is called indexing. The more pages of your website that are indexed the more chances your website will appear in search results. If your site is not indexed, it will not appear in searches.

The last step the search engine uses is ranking. Google uses 255 ranking factors in their search engine. Ranking decides what order your search engine results page (SERP) are displayed. The user

types in keywords in the search engine and it them gives a list of results. The order of the list is determined by the ranking factors.



What does this all mean?

When you develop your website you need to make sure the crawlers and spiders can find your website easily. You do this using Technical

Search Engine Optimization (Technical SEO) which is the infrastructure of your website. If you already have a website, you can do a Technical SEO audit. In most cases, once you get your technical SEO correct on your website, you won't have to deal with it again. Technical SEO is necessary, otherwise your website will not reach its full potential. Circuit Court Corner

Courts Move to Phase IV of Reopening Plan

On Monday, June 21, the State Court Administrative Office moved all courts in the State to Phase 4 of their four-phase Return to Full Capacity Plan. The pertinent Local Administrative Orders restricting court activities, including jury trials, were administratively closed and rescinded, and replaced by directives that all Court's comply with local county health department directives and MIOSHA requirements. MIOSHA, in turn, removed the majority of its mandatory restrictions as well.

Consistent with the Macomb County Health Department and MIOSHA, masks, social distancing, capacity limitations, and health screening will no longer be *required* to enter the County Courthouse, the Old County Building (location of Friend of the Court, the Juvenile Division, and the Legal Self-Help Center), 42-1 District Court, and 42-2 District Court. Individual judges retain the discretion to require masks, and any person who wishes to continue to wear a mask will be allowed to do so. Masks will continue to be provided if necessary or requested. Protective measures have been implemented, including installation of hand sanitizing stations, protective shielding, and physical barriers within court areas.

Individuals who have tested positive for COVID-19 or who are experiencing COVID-19 symptoms should contact the Court for further instructions. Individuals who have recently tested positive for COVID-19 or who are experiencing COVID-19 symptoms should not enter the building.

Chief Judge James Biernat and court officials will continue to monitor local COVID-19 data and adjust plans related to staffing and public access to court facilities, as needed.

16th Judicial Circuit Court (including Juvenile Division)

The 16th Judicial Circuit Court has resumed inperson proceedings. While proceedings are still being conducted virtually to the maximum extent possible, inperson proceedings, including jury proceedings, are now permitted and are resuming at the 16th Judicial Circuit Court.

Scheduling matters onsite or remotely will be determined by each individual judge, and will be reflected in hearing notices and on the judge's webpage. See: https://circuitcourt.macombgov.org/CircuitCourt-Judges

In-custody matters will continue to be conducted remotely unless an in person hearing is necessary.

The Circuit Court, including the Juvenile Division, the Macomb County Legal Self-Help Center, the Turning Point PPO Office, and the County Clerk's Office are open from 8:00 am to 4:30 pm.

Macomb County Friend of the Court

The Macomb County Friend of the Court will continue to conduct Referee hearings and motions, investigations, and enforcement hearings remotely to the greatest extent possible. The Friend of the Court office is open to the public from 8:00 a.m. to 5:00 p.m. from Monday to Friday. The office is open for walk-ins for child support enforcement, interstate, and medical enforcement from 9:00 a.m. to 12:00 noon, and from 1:00 a.m. to 4:00 p.m. Monday to Friday. Inquiries regarding the enforcement of parenting time should be made via email, mail, or fax. The Friend of the Court drop box is available in our lobby from 8:00 a.m. to 4:30 p.m. for all Friend of the Court documents, but no cash payments. Payments can be made in our cashiers department from 8:00 a.m. to 4:30 p.m. For more information please visit friendofthecourt@macombgov.org.

Macomb County Probate Court

The Macomb County Probate Court will continue to process emergency petitions remotely, new filings or pleadings to be filed can be mailed to the court or dropped off to a drop box on the 5th Floor of the

Courthouse. Additionally, the office will be open to the public from 1:30 pm -4:30 pm daily. If pleadings are left with a clerk, they will be date stamped as received only, nothing will be processed at that time. Judge Sandra Harrison will be conducting in-person hearings effective immediately. Please check our website for further information. https://probatecourt.macombgov.org/

42-1 District Court - Romeo

The 42-1 District Court has resumed in-person hearings; virtual appearances will be used for many proceedings going forward, such as informal traffic hearings and prelims on landlord-tenant matters. In-person hearings will be scheduled beginning in July for other proceedings, including jury trials. In-custody matters will continue to be conducted remotely unless an in person hearing is necessary. Notices for hearings will clearly indicate the type of appearance required. The Court hours are 8 to 4:30, closed from 12:00 pm to 1:00 pm. For payment options and other court information, please see our website at https://42romeo.macombgov.org.

42-2 District Court - New Baltimore

The 42nd District Court has resumed in-person proceedings, with the exception of landlord-tenant cases which will be conducted virtually. In-custody matters will continue to be conducted remotely unless an in person hearing is necessary. Virtual hearings will be granted upon request. Hours of operation are 8:30 a.m. to 5:00 p.m. For your convenience, the court remains open during the lunch hour between 12:00 p.m. to 1:00 p.m. There is an after hour drop box located in front of the courthouse for any court documents or payments.
